WITNESSETH

NOW, THEREFORE, RSPAD Gatot Soebroto College Of Health Sciences Jakarta Indonesia and Prince Of Songkla University (PSU) Pattani Campus, Thailand, in consequence of the above premises hereto agree to jointly develop and implement **Research And Community Service**, as they have agreed on the following:

Article 1

General Stipulation

In this Memorandum of Agreement, the partnership between **RSPAD Gatot Soebroto College Of Health Sciences Jakarta Indonesia and Prince Of Songkla University (PSU) Pattani Campus, Thailand** defines as cooperation in term of education development.

Article 2

Objectives

This Memorandum of Agreement is expected to improve institutional relationship between the two parties to be able to mutually contribute in the human resource development and the quality improvement of institution to fullfill the international education standards.

Article 3

Scope

Article 4

Implementation

1. The implementation of this agreement would be specifically and further defined by both parties.
2. The implementation of this agreement can be discussed by two parties in Indonesia or in Malaysia.

Article 5

Funding

Costs arising from the implementation of the activities of this Cooperation Agreement shall be borne by both parties, in accordance with the functions, duties, obligations and rights of both parties.

Article 6

Terms

1. This Memorandum of Agreement shall be valid for 2 (two) years, and taking effect from the date the agreement signed by both parties. The agreement might be automatically extended, changed, or canceled at any time, agreed and approved by involve both parties upon in writing.
2. This Memorandum of Agreement shall be terminated if there any clause or term of it that is in contradiction with the Indonesia and Thailand regulation.

Article 7

Problem Solving

Should there be any conflict regarding this agreement occurred between the two parties, discussion and deliberation would be chose to solve the conflict.

Article 8

Others

1. The commitment made between the two parties in this agreement is subject to the capability of each party while obeying the agreed rules and regulations.
2. Other related matters that has not been arranged, would be further discussed by both parties.
