# **Memorandum of Understanding**

Under this Memorandum of Understanding (MoU), the two institutions may proceed to implement the following endeavors :

## **Proposed Areas of Cooperation**

1. Joint training, seminar, workshop and publications.
2. Student mobility/exchange programme; e.g. study abroad, internship, study visit, etc.
3. Development of study pathways including curriculum mapping and credit transfer.
4. Faculty staff mobility including e.g. guest lecture or co-lecture.

The specific activities to be undertaken shall be covered by a corresponding Memorandum of Agreement (MoA) and the activity must commence within six (6) months from the date of this MoU, failing which, this MoU may be deemed as null and void.

Both parties understand that all financial arrangement will have to be negotiated and will depend on the availability of funds.

This MoU shall take effect upon signing by both parties and shall remain in force for a period of two (2) years subject to renewal upon mutual consent unless sooner terminated by either party provided that a written notice shall have been served at least sixty (60) days before such termination takes effect.

This MoU is not legally binding and entered into by the parties herein to merely express their intention to collaborate and is therefore subject to the parties herein entering into a legally binding MoA. Nothing contained herein shall be construed as a joint-venture and shall not constitute either party as the agent of the other.

Hereupon the signatures of the representatives of both institutions are affixed with the hope of promoting mutual cooperation effective from **21<sup>th</sup> day of February 2024**.
